## **CALL FOR PAPERS**

### **2ND INTERNATIONAL SEMINAR ON HISTORIAN HERITAGE**

The Victorino Fabião Vieira Association, AVFV, in partnership with the School of the Federal Attorney General's Office is organizing the “2nd International Seminar on Historical Heritage”, together with the Brazilian Forum of Cultural Tourism.

The events will take place in Porto Alegre, on May 14, 15 and 16, 2025, with the main objective of promoting debate, under interdisciplinary analysis, on the instruments, means and justifications for the Preservation of Historical Heritage.

Students, professionals and the general public are invited to participate in an event that will bring together national and international speakers, as well as researchers who will present their works and proposals for the protection of heritage.

#### **THEMATIC AXES**

The thematic axes adopted for the selection of papers are the following:

- A) Heritage Legislation;
- B) Heritage Education;
- C) Restoration-Conservation,
- D) Cultural Tourism.

#### **FORMAT, CONTENT, EVALUATION AND ACCEPTANCE**

The papers submitted for submission will be evaluated by the scientific committee as long as they deal with themes related to the axes proposed by the event and are in accordance with the publication standards. These will be submitted to two evaluators for blind evaluation. If they receive favorable opinions and are approved for the Seminar, the papers will be included in the event's e-book. The paper containing an experience report or ongoing or completed research must follow the ABNT standards,

containing a minimum of 10 and a maximum of 20 pages with 1.5 spacing and Arial 11 or Times 12 or 14 font. The papers must follow the following order: 1) Title; 2) Authors and Author Information; 3) Summary; 4) Keywords; 5) Abstract and key words; 6) Introduction (or presentation); 7) Method (or methodological options);

Results and discussion;

Conclusion (or final considerations); and;

References.

The first page of the paper should contain the name of the author(s) and their academic and professional references. The titles of the items should be typed in bold, with the text according to ABNT standards.

The abstract should be presented in Portuguese and English with a maximum of 200 words and between 3 and 5 keywords.

Introduction. This involves introducing or presenting the problem that guides the research/intervention and that gives meaning to the methodological options.

Method (or Methodological options). After discussing the research/intervention problem, it is expected that the research or action paths will be explained.

A methodological debate on research tools or instruments is not necessary; it is enough to indicate the reasons for the choice and the reference authors that were used).

Results and discussion: analyzing, evaluating and discussing the data obtained and synthesizing them into information and knowledge relevant to the proposed problem.

Conclusion (or Final Considerations): consists of resuming the problem presented in the introduction and highlighting how the results and discussion contributed to its resolution, expansion or future directions.

References: Only for cited bibliography. Single-spaced, with no spaces between citations and no indentation. Follow ABNT 2002 – (NBR 6023/2000).

Contact information. When submitting, provide a contact telephone number, which will not be published in the article.

Text format. Texts should be submitted in Microsoft Word 97/2000/2010XP (.doc), OpenOffice.org Text Document (.sxw or .odt) or Rich Text Format (.rtf), formatted for A4 page (210 x 297 mm), with top and left margins of 30 mm and bottom and right margins of 20 mm.

## PRESENTATION OF PAPERS

The selected papers must be presented in up to 15 minutes in the groups previously indicated by the organizing committee. It is essential that the presenters are present until the end of the presentation session, thus ensuring their debate and in-depth analysis.

The author may use audiovisual resources, projectors, or PowerPoint for the presentation.

Each axis will have a coordinator who will monitor the presentation of the papers and make their considerations.

Participants are advised to arrive at the presentation location in advance, as they will begin on time.

## PUBLICATION

The papers not selected for presentation or those selected but whose author is not interested in presenting will be published in Special Editions of the following journals (each selected paper will be published in one of the indicated journals, as selected by the Editorial Board) : A) Municipal Law Magazine; B) Magazine of the Historical and Geographic Institute of RS;

## EVALUATION CRITERIA

The Selection Committee will observe the following criteria to select the papers:

Presentation (Title consistent with the content).

Abstract: presents, in a concise and clear manner, the theme and central ideas.

Content (Adequate introduction allowing understanding of the theme, structure of the text, analysis methodologies and bibliographic sources. Concise and complete work, but not verbose. Theoretical consistency in the approach to the theme.

Correspondence between the conclusion and the arguments presented in the development of the text). Originality/Innovation;

Deadline for Submitting the Abstract is 22.02.2025.
